Call to order: Audrey called the meeting to order. Seven board members and five others answered roll call. All present were given a written agenda, secretary and treasurers reports, contribution, endowment report and a 2007 annual narrative report; all division reports for corporate, education, building and grounds, and museum were also included. Minutes of the preceding meeting: Pamela made a motion to approve the minutes as written and Laverne seconded the motion. Motion carried.

Treasurer's Report: Wanda motioned to accept the written financial reports; Judy seconded. Motion carried. The March 31, 2008 balance in checking account was \$8,881.39; and savings was \$7,364.17.

Buildings and Grounds: Wanda had us each sign our name to thank you cards to be sent to the workers on the plumbing and installation of the water system. May 31st is our

clean up day in Manfred. A workshop for the museum help will be on May 30th. Audrey will help us to understand the museum equipment and how to operate it.

Gwyn made a motion to collect \$50.00 each from the five entities (MPH, Inc., Andersons, Ostrem, Audrey's-station, RVA –hotel lot) for gas and oil for the mowers that Esther and Wesley will be using for the mowers. Laverne made a motion to give them a donation of \$200.00 for their work; seconded by Verna. Motion carried. Pam was authorized to get an inexpensive or free tree to be planted in the Centennial Park in Harvey. There was also a motion for Wanda to put an ad in the Herald Press for a sink and other items for the kitchen. Laverne made the motion and Gwyn seconded. Motion carried.

Museum Directors Report: Wanda gave a tribute to Herbert Ongstad and others shared memories of times spent with Herb. We will all miss him. Pete showed us the rocking chair that Wanda found in the hotel. Pete and Perry refinished and covered the rocking chair that belonged to Nennie Johnson. A beautiful job of restoration was done.

Wanda mentioned that the Newsletter would possibly be ready for folding and sending near the last week of May.

Historian Report: Audrey mentioned that collecting history is very interesting for her.

Election of Officers: Audrey asked that the present officers keep their jobs. After calling three times for any additional names, Gwyn made a motion to cast a unanimous ballot for the present slate of officers; Pam seconded. Motion carried.

Wanda, Ruth and Pam were nominated as directors for next 3 years. Approved by all present. Wanda made a motion to give \$25.00 to Harvey Community Foundation. Ruth seconded. Motion carried.

Laverne made a motion that MHP pay the telephone bill starting now with the hook-up. Pam seconded. Carried.
